No.V-TEX-03/2020 1047 /H,T&H, Sri Sukumar Behera (SC), Sub-Assistant Registrar Cooperative Societies(SARCS), Office of the Assistant Director of Textiles, Baripada, Mayurbhanj who has been promoted to the post of Assistant Director (Legal), Group- 'B' in the Level-11 of the pay matrix under ORSP Rules, 2017 vide this Department Notification No.8613/HT&H dated 31.12.2019 and on promotion posted as Assistant Director (Legal) in the office of the Director of Textiles and Handloom, Odisha, Bhubaneswar against the existing vacancy vide this Department Notification No.8614/HT&H dated 31.12.2019 had represented to the Commissioner-Cum-Secretary to Government, Handlooms, Textiles & Handicrafts Department on 07.01.2020 through proper channel to forego his promotion to the post of Assistant Director (Legal) on health ground of self among others.

After careful consideration, Govt. have been pleased to allow Sri Sukumar Behera to forego his promotion to the post of Assistant Director (Legal) subject to the following stipulation in terms of Office Memorandum No.24519-S.C./6-35/99-Gen.dated 20th August, 1999 of General Administration Department.

- (i) The option of Sri Sukumar Behera, Sub-Assistant Registrar of Cooperative Societies(SARCS), to forego promotion to the post of Assistant Director (Legal), Group-'B' is once and for all.
- (ii) The foregoing of promotion shall not be conditional.
- (iii) His services may be transferred from the present station/Office as and when Government desires in the interest of public.
- (iv) The resultant vacancy may be filled up by elevating the next eligible and suitable employee to the rank of of Assistant Director (Legal), Group-'B'.
- (v) This Notification may be recorded in the service book of Sri Sukumar Behera and a copy of it pasted on his service book for future reference of all concerned.
