**RESOLUTION**

**Sub: Creation of one post of Deputy Director of Textiles (Promotional) in lieu of abolition of one post of Asst .Director of Textiles in the Textile Cadre.**

The restructuring of the Odisha Textiles Service cadre was under consideration of the Government on account of exigencies of public service and in the light of activities in the handloom sector in Bargarh District including the functioning of Sambalpuri Bastralaya, Bargarh and other important projects.

Government after careful consideration have decided to create one post of Deputy Director of Textiles (Level-13) at Bargarh in lieu of abolition of one post of Assistant Director (Promotional), Level-10 in the Textile Cadre.

Accordingly, the cadre strength of the Odisha Textile Service with break up of Existing Strength and revised strength will be as follows.
