On the recommendation of the Odisha Public Service Commission and in pursuance of the Odisha Textiles & Sericulture (Method of Recruitment and Conditions of Service) Rules, 1993 and subsequent amendments, the following candidates are hereby appointed as Assistant Director of Sericulture, Group-B in the Cell-1 of Level-10 of the Pay Matrix under the ORSP Rules, 2017 in the scale of pay of Rs.44,900/- with usual D.A. and other allowances as admissible from time to time on ad-hoc basis for a probation period of 02(two) years from the date of their joining in the post.
