Consequent upon amalgamation of Handicraft Sector with the Handloom, Textiles and Handicrafts Department as per GA &PG Department Notification No. 24622 dated 19.12.2011 a total of 362 nos. of posts of different categories have been transferred from MSME Department to HT&H Department vide this Department Resolution No. 219 dated 14.01.2020, Resolution No. 4570 dated 20.08.2020 and Resolution No. 5222 dated 22.09.2020 with the concurrence of Finance Department. The transfer of balance posts were under consideration of Government.

Now, keeping in view the requirement of senior level officers, Government have been pleased to transfer 16 nos. of District Cottage Industries Officer (Level-I) posts(with grade pay of 6600 in L-13) from MSME Department to HT&H Department to further strengthen the Directorate of Handicrafts and Handicraft field offices for the development of Handicraft Sector. These posts would be re-designated as Deputy Director Handicrafts.
