**Advertisement for re-engagement of retired Deputy Secretary in HT&H
Department**

Application in the prescribed porforma (as per Annexure-I) are invited from the eligible retired Deputy Secretary having professional excellence and working experience in different Departments of Odisha State Government for re-engagement in Handlooms, Textiles & Handicrafts Department, Government of Odisha for a period of one year or filling up of the vacancy of Deputy Secretary whichever is earlier as per the details given below.

1. Age : The age of the applicant should not be more than 65 years.
2. Remuneration : The candidate who will be re-engaged in the HT&H Department shall be paid monthly consolidated remuneration @ Rs.30,000/- (Rupees Thirty thousand) only. No other allowances like D.A. , HRA, T.A., Medical Reimbursement etc. will be admissible. Facilities like transport and residential accommodation would not be provided.
3. Tenure : The tenure of such re-engagement shall be for a period one year or filling up of the vacancy of Deputy Secretary whichever is earlier.
4. Departmental Proceedings if any : The retired officer against whom vigilance case or Departmental proceedings or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period upto ten years preceding his/her retirement, or is a member of a Political Party will not be considered for re-engagement.
