RESOLUTION

No.HTH-HLS-HD-0039-2018/ 8965 /HT&H, Bhubaneswar, dated the 07.12.2023

A detailed Guidelines for implementation of the scheme "Mukhyamantri Bayan Jyoti Yojana" was issued vide this Department Resolution No.8248/HT&H dated-28.12.2021.

It was constantly demanded by the beneficiaries to amend certain provisions in the Guideline for larger benefit of the weaver community.

After careful consideration, Govt. has been pleased to amend the following provision to make the Guidelines proper for the benefit of the weaver community.

1. Para 6. ELIGIBILITY CRITERIA:

Para 6.1(v): " is deleted."

2. Para 6.3: is substituted as follows:

"As functioning of inverter requires electricity, it may be ensured that the beneficiary household must have consumer number in the name of any member of his/her household or in the name of his/ her father/ mother/ brother/ sister/ grandfather/ grandmother including in-laws under these categories from respective electricity distributing agency engaged by Govt. and have paid electricity charges for the last one year."

Order:- It is ordered that this resolution be published in an extraordinary issue of the Odisha Gazette of the Government of Odisha for the general information and copy be communicated to all Departments of Government/ all Heads of Departments and other concerned.




