The reelable tasar cocoon is considered as the high grade cocoon used as quality raw material and having a great demand among the tasar weavers of the State.

Earlier, the scheme "Reimbursement Cost on Procurement of Reelable Tasar Cocoon" commenced in the year 2012-13 which envisaged to provide an additional incentive bonus to tasar rearers @ ₹ 0.25p for each reelable tasar cocoons which are sold to the primary credit societies in order to encourage the farmers for production of high grade reelable tasar cocoons, which will help in providing quality raw materials to the weavers of the State.

In order to supplement the income of the tasar rearers and to override illegal market force involved in smuggling of tasar cocoons, the State Government have been pleased to enhance the incentive bonus on reelable tasar cocoons from ₹0.25p to ₹1.00 for each reelable tasar cocoon on sale to a primary society, limited to the approved project cost of Rs. 60.00 lakhs per annum.
