RESOLUTION

No. HTH-HLS-HD-0039-2018/ 1673 /HT&H, Bhubaneswar, dated the 07.03.2024

A detailed Guidelines for implementation of the scheme "Mukhyamantri Bayan Jyoti Yojana" was issued vide this Department Resolution No.8248/HT&H dated-28.12.2021 and subsequent Resolution No.8965/HT&H dated-07.12.2023.

It was constantly demanded by the beneficiaries to amend certain provisions in the Guideline for larger benefit of the weaver community.

After careful consideration, Govt. has been pleased to amend the following provision to make the Guideline proper for the benefit of the weaver community.

1. Para 11. DISBURSEMENT :

Para 11.3: is substituted as follows:

" After sanction is accorded, the funds will be transferred directly by the Zonal Officers to the bank account of the beneficiaries through DBT Mode in two installments ", i.e.

1. 1st installment, Rs.10,000/-for purchase of equipment.
2. 2nd installment,Rs.7,500/- after purchase of equipment.

Order:- *It is ordered that this resolution be published in an extraordinary issue of the Odisha Gazette of the Government of Odisha for the general information and copy be communicated to all Departments of Government/ all Heads of Departments and other concerned.*
